BOARD BRIEFSJanuary 18, 2008

The Executive Board Meeting was held at Seton Hill University on Friday, 18 January 2008. Following are the highlights:

- Evaluation results from the 2007 Annual Conference were reviewed and discussed as planning for the 2008 Annual Conference in State College, PA begins. Conference co-chairs are Jamie Rossi, Carnegie Mellon and Sarah White, EMC. Conference dates are 19, 20, and 21 October.
- Jan Schumacher, President, continues to drive the strategic plan development with President-Elect, Dan Kennedy. Key points: diversity of membership, development of committees, collaboration, and orientation/integration of Executive Board members.
- Joe Puzycki, Treasurer, reported that the total assets are \$22,087.65. Annual conference report also presented; total income realized was \$1,160.34.

Past President, Todd Eicker is soliciting nominations for Executive Board vacancies.

- Membership Commission Chair, Amber Valentine, reported 157 members. Graduate student numbers have continued to decline; decline in other areas also. Discussion of strategies to impact membership.
- Kate Linder, Constituencies Chair, plans to recruit members with legislation reviewing/reporting by marketing the broad arena of this commission and how legislation impacts higher education in general and specific job responsibilities/areas of interest in particular.
- PCPA is co-sponsoring a "Suicide Prevention Workshop" with the PA College Counselors Association and the Student Affairs Office at Shippensburg. Workshop is scheduled for Friday, I I April at Shippensburg. Presenter is Laurie Davidson, M.A., Suicide Prevention Resource Center/Center for College Health and Safety, Newton, Mass. Watch for details about this professional development offering!

BOARD BRIEFS April 6, 2008

The Executive Board Meeting was held at the Nittany Lion Inn on April 6, 2008. Following are the highlights:

- Conference co-chairs Jamie Rossi, Carnegie Mellon and Sarah White, EMC. reported from the 2008 Annual Conference planning meeting earlier in the morning. Discussed costs to members and graduate students as well as changes to some of the programs.
- Jan Schumacher, President, distributed information about desired insurance coverage for each state division. It is an "all or nothing" policy; all state CPAs must provide annual reports to provide the necessary information the insurance company needs to produce a quote. Also discussed a dual membership program wherein PA ACPA members could simultaneously join PCPA online when renewing their ACPA membership. Pros and cons were discussed.
- Joe Puzycki, Treasurer, reported that the total assets are \$22,551.68. Shared two letters of thanks from the UPJ President and the Secretary of the Foundation on behalf of PCPA's donation to the Dr. Brenda Pardini Scholarship.
- Past President, Todd Eicker reported that elections will begin today. There is at least one person running for each vacacny.
- Membership Commission Chair, Amber Valentine, reported 163 members an increase of 6 members since January's meeting.
- Kate Linder, Constituencies Chair, gave updates on on the PA Victims of Crime Act funding; PA House Bill 606 (greater control of liquor sales by businesses); PA Senate Bill 1250 PA Constitutional Amendment (proposes to forbids same-sex marriage and civil unions); House Bill 725 (PA House Liquor Control Committee requires all PA colleges to implement written alcohol policies regarding student and ensure that each student receives a copy; and a federal case Love vs. Morehouse College institutional liability case. Also mentioned the movement for concealed weapons being permitted on campuses.
- President Jan Schumacher thanked Dr. Lunardini for his wisdom, guidance and years of service to PCPA, to the students, and to the state. Also welcomed Dr. Linda Hall to the Board; Dr. Hall will serve as the Executive Board Faculty Liaison. For his final report, R. Lunardini noted that he would recommend that we continue to recruit members via the chief student affairs officers; suggested that we send the newsletter to the CSAOs. R. Lunardini thanked the Board for the past 12 years.

Eligibility

Procedures

The topic of the award is a major issue in Student Affairs.

Submit (2) copies of the manuscript.

Entries will be judged on originality, clarity, significance of the topic to the field of Student Affairs, technical competence, and forcefulness of argument.

Students

Constituencies Commission Corner

Greetings! Please take a few moments out of your busy schedule to check out some current legislation affecting higher education:

Victims of Crime Act (VOCA) Funding in PA

VOCA was enacted by Congress and President Reagan in 1984 as a <u>non-tax payer</u> funded source for services that help victims of crime recover from trauma. The funding for VOCA comes from a variety of federal criminal fines, forfeitures, assessments, and penalties. The program is national and serves as a major funding source for domestic and sexual assault violence programs across our state.

President Bush has requested that the VOCA balance be rescinded with the money being moved to the general treasury by 2010. This request comes at a time when operating costs are increasing and demands remain high for the services which are provided by domestic violence programs such as shelters, counseling, advocacy and hotline calls. Without VOCA funds many domestic violence/ victim services across PA will have to reduce services or close completely.

To speak out in support of maintaining VOCA funding for domestic violence and victim services, contact your congressional representatives and urge them to deny President Bush's request. Take it further and ask for an increase in the VOCA cap to \$1 billion (this would reallocate funding that already exists and will not impact taxes). Our students can benefit greatly from domestic violence/victim services, so our advocacy is important!

PA House Bill 606

This Bill has passed the House and is pending in the Senate and represents greater control of liquor sales by businesses. The Bill increases the current fines for alcohol sales to minors, sales after hours, and sales to intoxicated persons from a range of \$1000 to \$5000 to \$2000 to \$10,000. The Bill also requires the county court to follow decisions made by the Pennsylvania Liquor Control Board (PLCB) unless an error of law or an abuse of discretion is committed. Currently, the county court can decide cases without regard to PLCB decisions. Finally, the Bill requires managers of restaurants, eating place retail dispensers of alcohol, and hotel, club or distributor licensees to complete the manager training component of RAMP (Responsible Alcohol Management Program). Currently, participation in RAMP is voluntary. Stay tuned for an update on the Senate vote. (Note: the source for this information is Kenneth Healy, Pennsylvania Liquor Control Board)

PA Senate Bill 1250 - Pennsylvania Constitutional Amendment

This Bill proposes to forbid same-sex marriage and civil unions by amending the Constitution of the Commonwealth of PA to define marriage as being between one man and one woman. If passed the Bill may impact other forms of relationship recognition, such as domestic partner benefits by putting union-bargained contracts which currently recognize domestic partners/civil unions at risk. On March 18, 2008, the Judiciary Committee voted 10 to 4 in favor of this Bill. The Bill now goes to the House for a vote.

House Bill 725 (PA House Liquor Control Committee)

In February 2008 the PA House Liquor Control Committee approved this Bill which would amend the state liquor code to require all PA colleges, universities, and community colleges to implement written alcohol policies regarding students and ensure that each student receives a copy. Colleges that fail to do this would be ineligible for grants from the PLCB's alcohol education fund.

The written policies would need to include: a summary of the state's liquor laws and penalties for underage drinking (UAD), purchasing alcohol for minors, DUIs, and providing false ID to purchase alcohol; note that violating UAD will result in counseling on a first offense, education and probation on a second offense, and a one-semester suspension with a prohibition for seeking state financial grants on the third offense; each student must receive a copy upon enrollment and each semester thereafter; the written notice much describe the link between excessive alcohol use and auto accidents (injury and death) and sexual assaults of students.

House Bill 725 is sponsored by Rep. Ron Raymond, R-Delaware, and will soon be coming up for vote in the House.

Love vs Morehouse College (2007)

According to the February 22, 2008, Chronicle of Higher Education (p A31), former student Gregory A. Love sued Morehouse College because he contended that the institution was liable for injuries he received in 2002 when another student attacked him in a residence hall shower. Love stated that the attack resulted because the aggressor perceived him to have made a homosexual advance. Love claimed in his suit that Morehouse had fostered intolerance towards gay students either deliberately or through ignorance and did not address reported incidents of harassment and homophobia.

A trial court dismissed Love's case, but in October 2007 the Georgia Court of Appeals reversed the dismissal. This reversal signals that if evidence is produced to support Love's claim, he may be entitled to damages from Morehouse. (The aggressor has already been convicted of aggravated assault and battery.)

The perspective articulated by Morehouse is that the incident related to matters of "morals and virtue" for which the institution does not have increased responsibility.


Any decision on this case will only affect Georgia law but could certainly influence whether or not similar lawsuits are filed in other states. The arguments made by Love could be applied in situations involving a plethora of personal characteristics (for example, race, religion, ethnicity, etc). Also, if the court finds in favor of Love, the decision may become grounds for legally requiring that higher education institutions teach tolerance and address harassment aggressively.

Social Networking for Student Affairs

In the past five years, according to a January 3, 2008 report by the Pew Internet & American Life Project, "social networking sites have rocketed from a niche activity into a phenomenon that engages tens of millions of internet users." These sites are "an online place where a user can create a profile and build a personal network that connects him or her to other users." The most well-known and most utilized sites include Facebook.com and MySpace.com.

The social network phenomenon had its genesis on college and university campuses. Remember when you needed an edu email account to join an institution's Facebook.com network? Nowadays, most of the major networks do not have such restrictions. While this has allowed membership to skyrocket, the open door policy has diluted their impact for specific audiences.

For student affairs administrators this problem has now been solved with the introduction of **iStudentAffairs.com**, launched in February 2008 as a social networking site for student affairs professionals that connects friends and colleagues with each other. Within a week of its introduction over 400 people joined, demonstrating the need and desire for this type of network. Individuals must register and be approved to access the site. Why are people asked to register? This is to ensure the integrity of the site. By keeping out spammers and advertisers, the focus remains on people interested in joining a community involved with higher education.


The response to the site has been overwhelmingly positive. Alex Herzog, Director of Campus Card Services at the University of Nevada – Las Vegas stated, "I can't believe this site didn't come about sooner. It's a great resource for student affairs professionals and I

personally like the ability to reconnect with colleagues in the field. I think this application is more personal and applicable for student affairs administrators than Facebook."

Once people are registered, they can share program ideas, views on policy matters, photos, discussion forums and more. Within the first few days, dozens of interest-based groups that reflect personal interest or professional responsibilities were formed. These include such functional areas as residence life, career services and academic advising as well as a number of groups to connect alumni of graduate preparation programs. Personal blogs have been created, which are featured on the main page, as well as a wide variety of videos. "By combining member pages, photos and videos, and blogs this social network merges the best of Facebook, Myspace, Blogger, Livejournal, and Wordpress," states Will Barratt, Associate Professor of Educational Leadership at Indiana State University. "This is the good stuff." **iStudentAffairs.com** also provides, what the Pew report classifies as "public and private communication tools." There is a built-in email system to correspond within the network, catch up with friends and surprise long lost colleagues. Individuals can also post messages to entire groups or write a post directly on someone's My Page bulletin board, known as a Comment Wall.

The goal of **iStudentAffairs.com**? Continued growth with the desire to become the social networking site for student affairs professionals, where connecting, sharing, and collaborating will be commonplace.
